Do Something, Inc ("the organization") is a not-for-profit Organization founded in 1993 to advocate and promote youth social leadership, community activism and citizenship Today it is also known as DoSomething org, and is one of the largest organizations in the United States that helps young people rock causes they care about A driving force in creating a culture of volunteerism, DoSomething org is on track to activate two million young people in 2011 By leveraging the web, television, mobile and pop culture, DoSomething org inspires, empowers and celebrates a generation of doers teenagers who recognize the need to do something, believe in their ability to get it done, and then take action The services are largely directed to young people (ages 13-25) who want to make a difference, but need help actively participating and leading in community change efforts There are some programs for established social entrepreneurship, as young people look largely to their peers for role models

DoSomething.org had another very successful year in 2011. We decided to focus on our campaigns - they are national "calls to action" that never require money, an adult or a car and they must have a measurable impact in the world. Each of our campaigns aims to reach millions of young people and activate at least 100,000 to take action and report back to Do Something. In 2011, we ran 16 campaigns, up from 12 the year before, and had over 2.4 million young people participate in our programs. Some of our new & most noteworthy campaigns include - Our annual Teens for Jeans drive that empowered hundreds of thousands of teens to collect gently worn jeans and donate them, clothing one-third of all homeless teens in the US - A new campaign, our Epic Book Drive activated over 100,000 young people across the country to collect over 250,000 gently used books and donate them in order to better serve a library in the Recovery School District down in New Orleans- A Summer Scavenger Hunt, a first-time pilot and innovative use of mobile technology, which created a fun and exciting 11 day campaign challenging young people to take action around different causes. Over 75,000 young people participated, engaging in over 20,000 youth-led projects - A "Give a Spit" about Cancer campaign that focused on registering college students for the bone marrow database. Over 1,000 college campuses ran drives and we even had 8 matches, saving 8 lives!- Grandparents Gone Wired, a pilot campaign we ran during the holiday season to get teens to teach their grandparents or local seniors how to use important technologies. Other notable programs and accomplishments in 2011 include our grants, scholarship program, Boot camps, Do Something clubs, website content and the Do Something Awards. Our Do Something Awards was once again hosted by Jane Lynch and featured on VH1 during primetime. Our Clubs program grew extensively, ending the year with over 1,500 Do Something clubs in middle schools, high schools and colleges across the US. We also saw our website traffic double from the previous year, hitting nearly 1 million unique visitors per month, visiting our 20,000+ pages of facts sheet, action guides, campaigns and other content.
