In 2011, Room to Grow served 520 families and 565 children. These families visited the sites every three months for a total of approximately 1,652 visits, and received parenting information and support. 98 children graduated from the program during this time and 193 new babies were enrolled. The organization distributed 92,493 new and nearly-new baby items, including developmentally-appropriate toys, books, clothing and equipment. Room to Grow engaged more than 2,000 volunteers who performed a total of 8,284 hours of work to sort, clean, fold, and display donated items and assist with other organizational efforts.
