THE MISSION OF THE PARK AVENUE ARMORY IS TO SUPPORT AND PRODUCE NON-TRADITIONAL WORKS IN THE PERFORMING AND VISUAL ARTS THAT NEED THE FREEDOM OF UNCONVENTIONAL SPACES FOR THEIR FULL REALIZATION WITH ITS PALATIAL PERIOD ROOMS BY LEADING GILDED AGE DESIGNERS AND ITS SOARING 55,000 SQUARE-FOOT DRILL HALL, THE ARMORY ALLOWS ARTISTS TO CREATE, AND AUDIENCES TO EXPERIENCE EPIC, IMMERSIVE AND ADVENTUROUS WORK IN THE PERFORMING AND VISUAL ARTS THAT CANNOT BE DONE ELSEWHERE IN NEW YORK THE ARMORY SEEKS TO EXPAND THE POSSIBLILITES FOR ARTISTS BY PROVIDING A PLATFORM THAT ALLOWS THEM TO ALTER THE TRADITIONAL RELATIONSHIP BETWEEN AUDIENCE AND THE ART

AVENUE ARMORY HAS ARRIVED AS THE MOST IMPORTANT NEW CULTURAL INSTITUTION IN NEW YORK CITY " - THE NEW YORK TIMES A BRILLIANT FIRST FULL SEASON OF ARTISTIC PROGRAMMING IN THE WADE THOMPSON DRILL HALL INCLUDED A NEW MUSIC FESTIVAL CURATED BY VIRTUOSIC ENSEMBLE EIGHTH BLACKBIRD, WITH SYMPHO, ARGENTO CHAMBER ENSEMBLE, NEWSPEAK, STEVE SCHICK AND JOHN LUTHER ADAMS, AMONG OTHERS, A MIND-BENDING, MATRIX-LIKE INSTALLATION BY SOUND AND VISUAL ARTIST RYOJI IKEDA, THE UNPRECEDENTED SIX-WEEK RESIDENCY OF THE ROYAL SHAKESPEARE COMPANY, AND A DANCE TRIPTYCH WITH THREE ICONIC COMPANIES SHEN WEI DANCE SEEN IN NEW YORK WERE IT NOT FOR THE ARMORY RYOJI IKEDA'S THE TRANSFINITE THE ARMORY COMMISSIONED ITS THIRD VISUAL ART INSTALLATION RYOJI IKEDA'S "THE TRANSFINITE" PROVED, ONCE AGAIN, THE REAL NEED FOR A SPACE IN NEW YORK CITY TO PRESENT ART THAT IS EPIC IN SIZE AND SCALE VISITORS WALKED INTO THE DRILL HALL AND WERE IMMEDIATELY A PART OF THE ART, ENCOUNTERING A 45-FOOT HIGH X 60-FOOT LONG FREE-STANDING MONOLITHIC WALL ONTO WHICH WAS PROJECTED CONTINUOUS STREAMS OF BARCODES AND DATA THAT WERE SEAMLESSLY SYNCHRONIZED TO SOUND, FILLING THE SENSES ON THE WALL AND FLOOR OF THE "LOUD" SIDE, IKEDA FLASHED INTENSE, EXTREMELY FAST IMAGES ON THE "QUIET" SIDE, NINE PLINTHS STOOD WITH LCD COMPUTER SCREENS AND SPEAKERS PROJECTING SOUND WHAT FIRST MAY HAVE BEEN DAUNTING, IMPOSING, OR VISCERAL SOON BECAME FAMILIAR, CONTEMPLATIVE AND CALM VISITORS REMOVED THEIR SHOES BEFORE WALKING ON THE FLOOR AND BECAME SO MUCH A PART OF THE WORK THAT THEY WERE INSPIRED TO DANCE, DO YOGA, DAY DREAM, AND MEDITATE IKEDA HIMSELF EXPLAINED DURING HIS PUBLIC ARTIST TALK THAT HIS WORK IS ACTIVATED BY THE PUBLIC, THAT IT NEEDS PEOPLE IN ORDER TO COME ALIVE THE EXHIBITION DREW A HUGE AMOUNT OF PRESS WITH ACCOMMODATED ALL THE COMPANY'S REHEARSAL, ADMINISTRATIVE, AND PRODUCTION NEEDS THE THEATRE CONSTRUCTED WITHIN THE ARMORY'S VAST DRILL HALL ALLOWED THE ROYAL SHAKESPEARE COMPANY TO PRESENT AS YOU LIKE IT, ROMEO AND JULIET, KING LEAR, THE WINTER'S TALE, AND JULIUS CAESAR IN REPERTORY, EXACTLY AS PERFORMED IN THEIR OWN THEATRE IN STRATFORD, AND WITH VERY LITTLE ON-SITE REHEARSAL OR ADJUSTMENTS IN ADDITION, THE ROYAL SHAKESPEARE COMPANY'S RESIDENCY ENABLED PARK AVENUE ARMORY TO SIGNIFICANTLY EXPAND EDUCATIONAL PROGRAMS BY BRINGING "YOUNG PEOPLE'S SHAKESPEARE" PRODUCTIONS OF HAMLET AND COMEDY OF ERRORS TO 800 NEW YORK CITY PUBLIC SCHOOL STUDENTS GRADES 4-8 THROUGH PARTNERSHIPS WITH FOURTEEN OF THE CITY'S OUT-OF-SCHOOL TIME (OST) SUMMER ENRICHMENT PROGRAMS FOR HIGH-NEED STUDENTS THE VERY SAME ACTORS WHO PERFORMED IN THE FIVE MAIN STAGE PRODUCTIONS DELIVERED HIGH-ENERGY, ABRIDGED PRODUCTIONS OF A QUALITY RARELY SEEN IN CHILDREN'S THEATRE EACH GROUP OF STUDENTS PARTICIPATED IN PRE- AND POST-SHOW AND ON-SITE WORKSHOPS LED BY AN ARMORY ARTIST CORPS TEACHING ARTIST, ALONG WITH A TEACHING ASSISTANT AND TWO MEMBERS OF THE ARMORY YOUTH CORPS THE RESIDENCY ALSO FEATURED FOUR SOLD OUT PANEL DISCUSSIONS, HELD IN THE ARMORY'S HISTORIC VETERANS ROOM, INCLUDING A DISCUSSION WITH DIRECTORS PETER BROOK AND MICHAEL BOYD, A PANEL ON DIRECTING SHAKESPEARE, A DISCUSSION ON THE THEME OF FAITH IN SHAKESPEARE, AND A PANEL DISCUSSION OF THE CHALLENGES AND GLORIES OF GIVING SHAKESPEARE'S LANGUAGE LIFE DANCE AT THE ARMORY PARK AVENUE ARMORY'S FIRST FULL ARTISTIC SEASON CULMINATED WITH A TRIPTYCH OF DANCE EVENTS IN THE WADE THOMPSON DRILL HALL THAT HIGHLIGHTED THE WORK OF THREE DISTINCT NEW YORK-BASED CHOREOGRAPHERS SHEN WEI, ELIZABETH STREB, AND THE LATE MERCE CUNNINGHAM SEPARATED BY GENERATIONS AND BY GEOGRAPHICAL ORIGINS, THE THREE CHOREOGRAPHERS ARE CONNECTED AS VITAL CONTRIBUTORS TO POST-MODERN DANCE AND TO THE CULTURAL COMMUNITY OF NEW YORK CITY THESE THREE DANCE PRODUCTIONS SOLD OUT AND REACHED OVER 20,000 AUDIENCE MEMBERS THE ARTISTS WERE CHALLENGED AND ENGAGED BY THE SPACE AND PRODUCED NEW AND REIMAGINED WORK AFFORDABLE TICKET PRICES AND AN EXTENSIVE MEDIA CAMPAIGN BROUGHT IN A DIVERSE AUDIENCE, WITH SURVEYS SUGGESTING MANY OF THEM WERE A NEW AUDIENCE FOR DANCE ANCILLARY PROGRAMMING IN THE HISTORIC ROOMS, ALONG WITH SCHOOL AND FAMILY WORKSHOPS, ENRICHED THE EXPERIENCE FOR THE PUBLIC, INCLUDING 250 UNDERSERVED STUDENTS SHEN WEI DANCE ARTS THE DANCE TRIPTYCH OPENED WITH SIX PERFORMANCES BY SHEN WEI DANCE ARTS FROM NOVEMBER 29 TO DECEMBER 4, SHEN WEI DANCE ARTS PERFORMED FOR A TOTAL AUDIENCE OF NEARLY 3,400 PEOPLE SHEN WEI CHOSE THREE CONTRASTING YET CHARACTERISTICALLY INTERDISCIPLINARY, CROSS-CULTURAL, HIGHLY VISUAL WORKS TO PRESENT IN THE DRILL HALL THE FIRST PIECE, A RESTAGING OF "RITE OF SPRING", USED A LARGER, MORE OPEN STAGE THAN THE PIECE EVER HAD BEFORE, WITH AUDIENCES EMBRACING THE STAGE IN A "U " BRIAN SEIBERT OF THE NEW YORK TIMES REMARKED THAT, "THE MANY ENTRANCES AND EXITS ARE STRENGTHENED BY MOR SPACE AROUND THE FLOOR, A LARGER FRAME FOR MR SHEN'S HANDSOME COMPOSITIONS " SECOND WAS A RESTAGING OF "FOLDING", IN WHICH A CURTAIN DIVIDING THE DRILL HALL IN HALF WAS SLOWLY AND ALMOST UNDETECTABLY RAISED FOR THE CLOSING MOVEMENT OF THE PIECE, REVEALING AN IMMENSE, DARK EXPANSE THE DANCERS GLIDED SILENTLY DOWN THE TOTAL DEPTH OF THE HALL, FINALLY ASCENDING A STAIRCASE A FULL CITY BLOCK AWAY FROM THE AUDIENCE SWALLOWED UP BY THE VASTNESS, THEIR BLOOD RED SKIRTS AND WHITE PAINTED BODIES WERE SPOTLIGHTED IN A SEA OF BLACK SHEN WEI'S FINAL PIECE WAS A WORLD PREMIERE, DEVELOPED DURING HIS SIXTEEN MONTH RESIDENCY AT THE ARMORY AND COMMISSIONED BY PARK AVENUE ARMORY SPECIFICALLY FOR THE DRILL HALL "UNDIVIDED DIVIDED" USED THE ENTIRE FLOOR OF THE DRILL HALL THE PIECE WAS ACCOMPANIED BY AN ORIGINAL SCORE BY SO PERCUSSION VIDEO AND ANIMATION DESIGNED BY JOSH HOROWITZ, LAYNE BRAUNSTEIN, AND BLAIR NEAL WAS PROJECTED ONTO THE FLOOR "UNDIVIDED DIVIDED" INCLUDED SHEN WEI'S CHARACTERISTIC USE OF PAINT, HIS NATURAL BODY DEVELOPMENT MOVEMENT TECHNIQUES, AND ELEMENTS OF CHINESE OPERA AND CULTURE NEW IN THIS WORK, HOWEVER, WAS THE TOTAL LACK OF SEPARATION BETWEEN THE AUDIENCE AND THE DANCERS SHEN WEI USED THE ENTIRE SPACE BY BRINGING THE AUDIENCE INTO THE DANCE SPACE THE PIECE WAS PERFORMED WITHOUT A DISTINCT STAGE RATHER, THE 30 DANCERS PERFORMED ON 60 PANELS MEASURING 7FT X 7FT, WHICH TILED THE DRILL HALL, ALONG WITH A STRIP OF WHITE MUSLIN "CANVAS" STRETCHED ACROSS THE MIDDLE OF THE FLOOR, AND TWO ROWS OF LARGE PLEXIGLASS SCULPTURAL STRUCTURES THAT THE DANCERS INTERACTED WITH THE DANCERS MOVED AT TIMES IN SYNCH AND AT TIMES SEPARATELY, BUT ALL WORKED WITH THE SAME MOVEMENT VOCABULARY AND OBSERVED THE SAME SHIFTS IN DYNAMICS AND PHRASING THE AUDIENCE MOVED AT WILL BETWEEN AND AROUND THE DANCERS, CREATING MOMENTS OF INTIMATE ENGAGEMENT AND INDIVIDUALIZED EXPERIENCES STREB FROM DECEMBER 14-22, STREB EXTREME ACTION PERFORMED "KISS THE AIR!" FOR NEARLY 8,000
