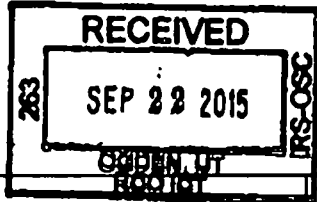

The site also includes Counseling Central, an area designed exclusively for college mental health and student affairs professionals. Currently, more than 1,300 colleges and universities participate in the Ulifeline network free of charge.
