In preparation of Form 1023, Application for Recognition of Exemption Under Section (501)(C)(3) of the IRS Code (Form 1023), the Foundation made the following representation:

"As required by the Pension Protection Act of 2007, as a non-functionally related Type III supporting organization, the Foundation will meet the private foundation payout requirements. It will distribute annually in grants to Bethlehem Township and Northampton County an amount equal to 5% of the value of its net investment assets. These grants will be earmarked for projects to preserve and maintain the Memorial Park and the County Park."

Because the Foundation agreed to comply with the Private Foundation Payout Requirements, we have enclosed, as information supplemental to the Foundation's 2011 Form 990, Parts X, XI, XII, XIII of Form 990PF for 2011, using the 2010 information to determine the minimum investment return for 2011 and the amount, if any, to be carried forward to 2012.

In addition, the Foundation also answered "yes" to question 6a on Schedule D of Form 1023, stating that "it distributes at least 85% of its annual net income to the supported organization(s)."

It is based on having made both of the above-noted representations in its Form 1023 that the Foundation is required to distribute the greater of 85% of its annual net income or the Private Foundation Payout Requirements. Accordingly, we have enclosed the particulars with regard to the Foundation's compliance with same.

In 2010, the Foundation elected to treat the \$68,056 in adjusted qualifying distributions, Line 6, Part XII of Form 990PF, as distributions out of corpus, Line 4c of Part XIII. Because the Foundation had no assets in 2009, its minimum investment return for 2010 was zero. In applying the 85% of net income rule, because the Foundation had no net income for 2010, it had no payout requirement with respect to tax year 2010. Accordingly, all of the Foundation's adjusted qualifying distributions in 2010 (which aggregated \$68,056) were "excess" distributions which the Foundation elected (1) to treat as distributions of corpus and (2) to carry forward to tax year 2011.

In 2011, the Housenick Foundation's minimum investment return was \$37,103, which represents 5% of its average investment assets held during 2010, as calculated in Part X of 990PF attached hereto. As reported in Part XIII of the 990PF for 2011, the Foundation applied \$37,103 of its excess distribution carryover to 2011 and elected to treat the remaining carryover amount of \$30,953 as corpus available for carryover to 2012.
