In 2011, the Walkkill Public Library provided 20,140 print materials, 90,873 electronic materials, as well as 4,458 other items as sources of information, education, entertainment, and cultural enrichment.

The Walkkill Public Library spent this money on new technology and hardware, including computers and internet services. In 2011, there were nearly 2900 in-library computer/internet users and in excess of 57,000 visits to the library's website.

Program offerings, primarily children's programs, make up the third largest portion of the program service expenses. In 2011, the Walkkill Public Library offered 557 adult, young adult, and children's programs. The total attendance for these programs was 7787 people.
