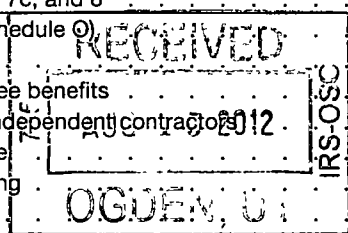



- 28 The Mohawk Valley Certified Development Corporation (MVCDC) is a not-for-profit corporation whose primary purpose is to assist business concerns that are located in the State of New York or will become located in the State of New York.

The corporation finances plant acquisitions, construction, conversion or expansion through federal and state-sponsored business assistance programs. The assistance includes processing applications for federal and state-sponsored business assistance programs, packaging and closing federal and state-sponsored loans and other similar financial management services.

To date, the Mohawk Valley Certified Development Corporation has assisted 41 small business concerns over a six-county region. Over \$12.68 million dollars has been loaned for building construction and renovations, land purchases, and major pieces of equipment. The financing has helped the six-county region create and/or retain 587 jobs.
