Propel My Life Additionally, more than 350 students attending camps in various states participated in Propel My Life, a teaching track offered by IMPACT 360 and taught by its alumni The goal of the leadership track is to encourage and equip high school students to have a more compelling and godly influence on their peers and propel them into a life of service and Christian community Topics include understanding worldview, how to engage culture with a Christian worldview, and presenting a servant leadership model of leadership Communities in Transformation (CIT) In 2011, CIT impacted 240 children total in four low-rent housing communities by training after school teachers in core essential curriculum, by providing camp discounts, by sharing areas of expertise with the community director, and by providing a CIT intern volunteer CIT also served to help empower and equip 20 of the community teenagers by providing complimentary training, speakers, modified core essentials curriculum, and provide a CIT intern volunteer
