OneAmerica works to build power in diverse ethnic communities in collaboration with
key allies. We do this through identification of and action on key issues that affect
immigrants. We bring immigrants together with the mainstream public and provide
opportunities to work for the common good and effect systemic change. Our 2011
priority issue areas included immigrant integration, racial profiling, and civil and
human rights generally. We also educate, mobilize and engage immigrants, identify
strong leaders, and develop their skills and abilities in order to help immigrants
better understand and participate in the democratic process.

In 2011, our major accomplishments in this area included substantial work on
immigrant integration: along with the National Partnership for New Americans,

We also provided English instruction in technology-based classes through our new pilot program, English Innovations.
