THE PURPOSE OF THE PROGRAM IS TO STIMULATE RESIDENTIAL GROWTH AND REVITALIZE THE LEVEE DISTRICT AREA. PURCHASERS OF NEW HOUSING UNITS (HOMES, CONDOS, TOWNHOUSES) IN THE TARGET AREA ARE ELIGIBLE TO RECEIVE AN INCENTIVE OF 10% OF THE PURCHASE PRICE UP TO \$10,000. IN 2011, GRANTS WERE GIVEN TALLING \$140,000

LAWRENCEBURG MAIN STREET, INC HAS AN ACTIVE IMPROVEMENT AND BEAUTIFICATION PROGRAM THAT INCLUDES GRANT PROGRAMS FOR COMMERCIAL AND RESIDENTIAL FACADE PAINT AND IMPROVEMENT, AS WELL AS, SIGNS AND AWNINGS. BUSINESSES ARE GIVEN 50% OF THE COST FOR PAINT/FACADE IMPROVEMENTS UP TO \$1,000. SIMILARLY, A BUSINESS MAY RECEIVE 50% UP TO \$1,000 FOR SIGNS AND AWNINGS. RESIDENCES WERE GIVEN 37 GRANTS. THE TOTAL FOR THESE PROGRAMS WAS \$46,583. A BUILDING IMPROVEMENT GRANT PROGRAM FOR MIXED USE PROPERTIES IN THE DOWNTOWN AREA. A \$25,000 GRANT WAS AVAILABLE. 12 APPLICATIONS WERE RECEIVED AND 12 GRANTS WERE FUNDED.

THE CONCERTS ATTRACTED PEOPLE FROM DEARBORN COUNTY AND THROUGHOUT SOUTHEAST INDIANA, AS WELL AS, NEIGHBORING OHIO AND NORTHERN KENTUCKY. THIS SERIES HAD BUILT COMMUNITY SPIRIT AND PRIDE AND HAS RAISED PUBLIC AWARENESS OF DOWNTOWN LAWRENCEBURG.
