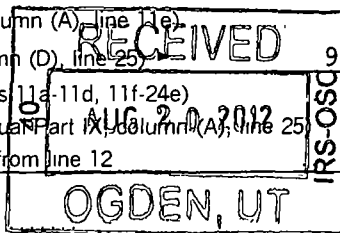

Those contracts call for children to improve their performance in at least one of four areas, such as improved academics, improved attendance, improved attitudes and behaviors or greater participation in after-school programs such as tutoring, Saturday school, or mentored programs (like sports). Elves & More focuses on at-risk children throughout Greater Houston and uses new bicycles as the principal way of doing this. Here's how:

Strengthening Education: We partner with Independent School Districts to let children earn bicycles through contracts with their teachers. Teachers set each child's specific goals-such as improved academics, better attendance, more-positive attitudes and participation in after-school activities; Students and their parents sign contracts to meet those goals. As the semester progresses, teachers use the contracts to motivate students. At semester's end, those students who meet their goals are rewarded with new bicycles from Elves & More. Students who participated in our 2009 earn-a-bike program consistently out-performed their peers in academics, attendance and attitudes.

Driving Intervention: In their own neighborhoods, at-risk children have many bad "mentors," such as drug dealers, gang leaders, ex-convicts and those who live lives on welfare or live in the streets. Sadly, they have too few good mentors. With a bike to provide badly needed basic transportation, an at-risk child's world gets much larger. Sure, bikes let kids play, but they also enable them to join after-school programs, attend tutoring classes, go to the library, and participate in church and community center activities of every stripe. At each of these, children encounter caring adult mentors who guide their lives in positive ways, encouraging them to stay in school and out of trouble.

Building Fitness & Health: By providing two wheels to serve as basic transportation and permit participation in after-school programs, our bicycles encourage children to

get out and ride, as well as participate in a host of other healthy activities which build muscle, burn fat and improve cardiovascular fitness. Studies show that healthier bodies lead to better performance in school. With more time spent in positive activities, the temptation to engage in drug use, crime and gang participation is greatly reduced, thereby reducing those health risks which plague at-risk kids, too.

115,771 Bicycles to date: During 2011, Elves & More gave 7,052 new bicycles to at-risk children, bringing its cumulative total of bicycles to 115,771 bicycles since the program's inception in 2000.
