In Idaho's Clearwater Basin, BHA is helping to shape the future for some of America's best backcountry habitat for elk, moose, black bear, native cutthroat trout, sea-run salmon, and steelhead. BHA is deep in a large scale planning process, involving a wide variety of stakeholders, to have robust legislative protection for wild places in the basin. Ideally, BHA's Clearwater Basin Collaborative could result in the designation of a Wilderness Area in Meadow Creek of between 250,000 and 400,000 acres, over 200 miles of wild and scenic river classification, and one half to one million acres of National Recreation Area status. These land and water protections will ensure that there are no new motorized incursions into this big, wild country.

4b (Code) (Expenses \$ 50,551 including grants of \$ 0) (Revenue \$ 44,500)

Backcountry Hunters and Anglers is protecting wildlife habitat and clean water by enhancing off road vehicle (ORV) enforcement activities on our nation's public lands. This is a four part program. 1) Develop and conduct an intense ORV enforcement information and awareness campaign within Montana. 2) Develop and seek a wide range of organizational participants in a sign-on letter to public land agency leaders requesting agency and policy maker commitment and action for stronger and effective ORV enforcement program. 3) Develop a comprehensive white paper of all available science on ORV impacts to public land resources. This document would consolidating science-based findings as a source document for non-scientists to be effective contributors to ORV related legal, enforcement and allocation processes. 4) Expand and improve effectiveness of BHA Watchman program as an important local eyes and ears connection to public land for improved ORV enforcement and non-motorized connections to local land management agencies.

4c (Code) (Expenses \$ 22,860 including grants of \$ 0) (Revenue \$ 0)

In Alaska, BHA is working with local conservation organizations, agency heads, and tribal leaders to protect a pristine salmon fishery on the Chitna River. An energy company has proposed rerouting the river from its natural bed into an adjacent drainage and strip-mining the exposed bed for coal, which it plans to ship to China. At least five species of Alaskan salmon spawn in these waters; disturbing their natal river could have an enormous impact on their survival and fishing opportunities in the area. BHA is manning an aggressive campaign to convince the public and tribal leaders not to sacrifice this vibrant and productive river.
