THIS ANNUAL SUPPORT IS USED FOR FOOD, CLOTHING, COOKING FUEL, EDUCATIONAL MATERIALS AND SUPPLIES. THF RAISED FUNDS IN OCTOBER OF 2011 FOR THE PURCHASE OF A NEW VEHICLE FOR THE TSOKNYI GECHAK LING NUNNERY ON CHOBHAR HILL, OUTSIDE OF KATHMANDU, NEPAL. THIS VEHICLE PROVIDES TRANSPORTATION FOR BUYING GROCERIES AND MDEICAL SUPPLIES. IT ALSO IS USED TO TAKE NUNS AS NEEDED FOR MEDICAL ATTENTION. THF AND ITS VOLUNTEER STAFF IN KATHMANDU HAVE ALSO ORGANIZED SEVERAL MEDICAL CAMPS AT TSOKNYI GECHAK LING IN 2011, PROVIDED WEEKLY MEDICAL CARE FOR THE YOUNG NUNS AND PROVIDED MEDICAL ATTENTION TO THE ADULT NUNS AS NEEDED. THE TSOKNYI GECHAK LING NUNNERY HAS 135 PEOPLE LIVING AT THE NUNNERY.
