The project involves the creation of paper bead jewelry that Voices for Global Change, through its Paper to Pearls initiative, sells in the United States and throughout the world

 Voices for Global Change raised money this year in support of an orphanage in Takeo, Cambodia that provides for the education of 135 children and teenagers.
