Compassion Connection is an international Christian missions organization that focuses on training and discipling God's people for evangelism, teaching and caring for the needy.

 Church Planting is a daily ministry of Compassion Connection involving the launch and growth of the local church in Quito called "La Fuente". It involves leadership development, mercy ministries to the local government hospital, weekly community group gatherings, as well as counseling, teaching and preaching God's word. In addition, Compassion Connection hosts yearly church training conferences and quarterly training sessions of those interested in planting churches. This program serves an estimated total of 5,900 people. With our hospital ministry 200 people per week (for 8 months) receive clothing, sandwiches, juice and prayer. The total also included the number of people participating in our conferences and attendees of the church. Financially speaking, we estimate that 45% of the use of the building project will be as a base of operations for church planting. Therefore, in addition to operating expenses for this program in 2011 we include \$58,940 used in construction of our new base.

4b (Code:) (Expenses \$ 81,200 including grants of \$) (Revenue \$)
 The Bible Institute program involves live teaching as well as "take home" lessons which are then gathered and graded on a monthly basis. The program utilized comes from the "Instituto Biblico de Capacitacion Internacional" (or IBCI) and they provide certificates after every year of completion ("Basic" after 1st year, "Superior" after the 2nd, and "Ministerial" after the 3rd). We run this program in multiple locations. The program goal is to train leadership in Biblical understanding with a bent on evangelism and church planting. The program also involves teacher training workshops so as to raise up future teachers to multiply Bible institutes throughout Ecuador. The number of people that participated in this program in 2011 was 100. Included in the expense portion of this program was \$40,000 or 30% of construction costs of our new facility, which will be a base of operations for IBCI in Ecuador.

 Short-term ministry is a program in which teams of volunteers come from the United States to help with the ongoing ministry opportunities of Compassion Connection. Their primary involvement focuses on community service projects, children's work, evangelistic ministry, construction projects, and mercy ministry efforts to help in the hospitals and among the needy in Ecuador. Some groups also come to attend a 2 week "missions camp" where they participate in the above activities but also they experience a program we have developed to educate / train in missions in a summer camp style. A fee is charged per person (see revenue) to pay for food, lodging, and transportation for this program. Short term missions / camps are usually about 6 weeks in duration total. Included as an expense in this program is \$30,000 which is about 25% of money spent on the building of our facility. It will serve as a base of operations (housing) for our short-term ministry program. It is estimated that 1,000 people received benefit from this program in 2011.
