

The figure of (14,006) represents an unrealized loss from the decreased value of our securities. Having invested \$20,000 to buy shares of renewable energy exchange traded funds, the value of our holdings as of 12/31/11 had sadly shrunk to \$5,994 (renewable energy stocks suffered greatly in 2011). To date this loss is unrealized, as we intend to hold on to these securities until their value returns.
