As the first and only Northwest regional provider of intensive exercise therapy, Pushing Boundaries continues to provide services to clients from five different states, including Washington, Oregon, Idaho, Colorado, and Alaska. In 2011, 6,624 hours of hands-on, intensive exercise therapy were provided including comprehensive programs involving manual and robotic gait training, electro-stimulated muscle activation, developmental neuro-reeducation and strength training, allowing clients increased independence and, often, to regain the use of paralyzed muscles. Outreach efforts to the medical community continue to benefit the paralyzed community with a high rate of physician and rehabilitation referrals, both in and out of the state of Washington. Continued increase in volunteer opportunities have resulted in circle of community collaborations and partnering with local businesses to provide a larger

care and more comprehensive involvement from the community through donations of time and services. Pushing Boundaries client programs were enhanced by approximately 1500 volunteer hours during 2011 including student exercise therapist internships from area universities. In addition to providing services at an affordable cost, Pushing Boundaries partners with social services and successfully works with clients to obtain partial reimbursement of costs for services rendered. However, the most significant accomplishments that we have made are the success stories of our clientele. The continued opportunities that Pushing Boundaries provides to our clientele is self-evident in the personal strides that each person continues to make in their road to increased health and improved quality of life.
