This initiative is planned as a series of events beginning in 2012 focused on Santa Fe's creative economy (The Santa Fe Series) and culminating in a world-class annual conference and cultural festival beginning in 2013 to be held in Santa Fe each year. The aim of IF is to explore the escalating significance and economic impact of culture (science, art, architecture, food, design, music, film, etc.) in the development of cities. The keystone of IF is the critical importance of generating bold new ideas about the ways culture can robustly inform and enhance urban development. Each cycle of IF includes conferences, cultural exchanges, and community outreach programs, as appropriate.
