

Clean, Safe, & Parking Lot Program -- Under contracts with the City of Yakima, and with the additional support of assessments paid by property and business owners in the downtown PBIA (Parking and Business Improvement Area), CDY cleans sidewalks, sweeps curb gutters, removes graffiti, monitors city-owned parking lots in the district for overtime or illegal parking, and otherwise maintains common downtown infrastructure daily. During this process, the CDY "purple shirt" maintenance workers also look for signs of illegal activity and notify the city police department when necessary.

Flowers & Plantings -- CDY plants and maintains 317 hanging flower baskets, all street level flower and shrub beds, corner concrete planters, and pocket green spaces in the city's urban core within the boundaries of the district as defined in the PBIA.

Downtown Revitalization & Event Coordination -- CDY helps business owners with advice on marketing, building and sign design, and whatever is requested to improve the business climate in the area. CDY also partners in downtown event planning to attract people to the area, sponsors a First Friday evening event monthly for downtown promotion, and serves as an umbrella organization to assist and support all downtown planning and project implementation.
