The Foundation served 271 (180 DV + 91 Non-DV) clients in 2011 alone providing them with case management, counseling, legal services, hotline calls and financial assistance. The Foundation was incorporated under the laws of the State of Texas. The Foundation pursues its objectives through the execution of these major programs: Outreach and Education: Social services including: hotline calls, counseling, case management, and financial assistance. The organization started providing transitional homes for clients in need. The Foundation provides Trainings and workshops about Domestic Violence within the Muslim Community to mainstream coalitions and organizations providing services to DV victims and to the Public and the Muslim Community.

4b (Code) (Expenses \$ 44,017. including grants of \$ 0.) (Revenue \$ 44,985.)

Domestic Violence Shelter: This program is designed to promote peace in the home and community through a comprehensive strategy of prevention and intervention. The shelter incurred expenses in 2011 in preparation for the scheduled opening of the shelter in June, 2012. Shelter expenses totaled \$44,017 as follows: (1) \$20,924 in payroll expense time allocated to personnel to ensure that the shelter property is operational and in compliance with all applicable codes. (2) \$15,482 in legal fees donated for setting up and establishing the shelter and the LLC mentioned in Note 3. and (3) 7,611 in other expenses.

The organization also provided Education and interfaith programs involving multi-generational (youth-adults-seniors) and multid denominational participants from the DFW Muslim and non-Muslim community.
