Many volunteer participants in western Ecuador assisted in collecting data on hundreds of animals, including several new species. Thousands of data points were taken and continue to be analyzed to produce and disseminate information to managers to make informed conservation decisions. Results were reported to the Ecuadorian government and are also reported at [www.BiodiversityGroup.org](http://www.BiodiversityGroup.org). Photographs and information on new and rare species were shared via our website and outreach programs

Our "PEEK" (Photography Educating and Empowering Kids) outreach program was developed and launched in Arizona and California so that local citizen scientists all over the world can soon join our use of photography for data collection to aid wildlife preservation in their areas.
