Targeting our income to effectively and efficiently achieve our goals we

- Subsidized member institutions who hosted Canadian studies scholars
- Helped sponsor a conference on the role of Canada in the NATO mission in Afghanistan
- Contributed to a Consortium for Pennsylvania Canadian scholars
- Promoted Canadian studies at meetings of the international Association for Canadian Studies in the United States in Ottawa Canada, November, 2011

The seminal event for our council is our biennial conference, which brings together MANECCS members, other U.S. Canadianists, and our cross-border colleagues to share research and perspectives on Canadian scholarship and pedagogical methods.
