Part I, Line 8, Other Income: \$1,755 of total revenue was received from the rental of organizations facilities. Skipp Pearson's facility was rented to Janice Rivers on July 30, 2011. Mrs. Rivers son passed away and memorial services were held at the organizations facility.

Part I, Line 10, Grants: \$13,570 of expenses were incurred to provide grants to 15 individuals enrolled in musical programs and pursuing a degree and career in jazz music. In addition to being enrolled in a musical program and pursuing a degree/career in jazz music, grant recipients must appear before Mr. Skipp Pearson and the organization's Executive Committee to answer questions and to perform so that a determination can be made on the individuals current skill level. The recipient must provide documentation to confirm that funds requested are to be used to further his/her jazz music education, purchase/repair jazz instrument or to gain experience in performing live.

Grant recipients for 2011 are Andrew Dykes, Buzz Clifford, C.J. Boykin, Chris Andrews, Elliott Adams, Jeff Elmore, Jeremy Roberson, Jon Palance, Nick Brewer, Phil Jones, Reggie Sullivan, Shannon Pickney, Steven Yelich and Zee Slaughter. Grant recipients are not related to any of the officers or committee members of the organization.

Part I, Line 16, Other Expenses: \$33,332 of total expenses were incurred to attend/perform conferences/board meetings, liability insurance to perform exempt concerts/events, office supplies, development of "The little boy who hated jazz" book series, performance of numerous free live jazz concerts within the Columbia area and travel to complete "Jazz on the Road" educational program meant to expose a broader audience to the rich history of American Jazz music.
