THE FOUNDATION FOR RECOVERY PROMOTES THE POSITIVE IMPACT OF ADDICTION RECOVERY IN THE COMMUNITY AND IN THE LIVES OF INDIVIDUALS AND FAMILIES AFFECTED BY THE DISEASE OF ADDICTION. OUR PROGRAMS, SERVICES AND PARTNERSHIPS OPEN PATHWAYS FOR RECOVERY BY REMOVING SOCIAL BARRIERS AND CREATING OPPORTUNITIES FOR THOSE SEEKING RECOVERY. OUR VISION IS THAT ADDICTION IS RECOGNIZED AS A TREATABLE DISEASE AND THAT INDIVIDUAL AND FAMILY RECOVERY IS SEEN AS AN ACCEPTABLE AND SOUGHT AFTER MEANS FOR ACHIEVING A BALANCED AND HEALTHY LIFE. THE FOUNDATION WILL HELP PREPARE AND ORGANIZE CURRENT AND FUTURE EDUCATORS, HEALTH CARE PROFESSIONALS, POLICY MAKERS, AND THE GENERAL PUBLIC TO MAKE THIS VISION A REALITY. THE FOUNDATION WILL PROMOTE AND HIGHLIGHT THE POSITIVE EXPERIENCES OF PEOPLE IN LONG-TERM RECOVERY AND FOCUS OUR PROGRAMS AND INITIATIVES ON FACILITATING THE BENEFITS OF RECOVERY FROM ADDICTION FOR THE INDIVIDUAL, THEIR FAMILIES, FRIENDS, EMPLOYERS, AND THE COMMUNITY.

	THE FOUNDATION FOR RECOVERY CONTINUED TO MAKE EXCELLENT STRIDES IN 2011 TOWARDS FURTHERING ITS MISSION AND VISION, AS WELL AS EXPANDING ITS PROGRAMS AND SERVICES. GENERAL PROGRAM EXPENSES IN 2011 WENT TOWARD THE FOLLOWING INITIATIVES: EDUCATION AND OUTREACH; THE FOUNDATION CONTINUES TO MAINTAIN ITS FACILITY, WHICH INCLUDES A RESEARCH, STUDY AND ARCHIVE CENTER, AS WELL AS A BOOKSTORE AND CLASSROOMS UTILIZED FOR PROFESSIONAL EDUCATION SEMINARS, PUBLIC EDUCATION SEMINARS, AND USE BY 12-STEP AND OTHER SUPPORT GROUPS. THE BOOKSTORE SELLS A MULTITUDE OF PRODUCTS RELATED TO RECOVERY TO THE GENERAL PUBLIC, STUDENTS AND OTHER ORGANIZATIONS, PROMOTING RECOVERY-RELATED ACTIVITIES. THE BOOKSTORE ALSO CARRIES A BROAD RANGE OF COMPLIMENTARY AND DISCOUNTED 12-STEP LITERATURE FROM NARCOTICS ANONYMOUS, NAR-ANON, GAMBLERS ANONYMOUS AND OVEREATER'S ANONYMOUS. THE BOOKSTORE SERVES AS AN INFORMATION CLEARINGHOUSE AT NO CHARGE TO THE PUBLIC, OFFERING A VARIETY OF EDUCATION AND OTHER INFORMATIONAL MATERIALS AND PUBLICATIONS FROM VARIOUS ENTITIES AND PARTNERS, INCLUDING THE SUBSTANCE ABUSE AND MENTAL HEALTH SERVICES ADMINISTRATION (SAMHSA), THE DEPARTMENT OF EDUCATION (DOE), THE PARTNERSHIP FOR A DRUG-FREE AMERICA, AND FACES AND VOICES OF RECOVERY. THE FOUNDATION FOR RECOVERY'S ARCHIVE HOUSES A LARGE SELECTION OF RECOVERY-RELATED MEMORABILIA FOR VIEWING AND USE BY THE GENERAL PUBLIC WITH INTEREST IN THE HISTORY OF RECOVERY OR RECOVERY RESEARCH. THE ARCHIVE CONTAINS THOUSANDS OF INDIVIDUAL PIECES TRACING THE RICH HISTORY OF NATIONAL AND INTERNATIONAL RECOVERY MOVEMENTS, OFFERING A WEALTH OF ORIGINAL SOURCE INFORMATION TO RESEARCHERS AND STUDENTS. THE ROOMS, AN INITIATIVE OF THE FOUNDATION FOR RECOVERY, MAKES MEETING ROOMS AVAILABLE TO THE 12-STEP COMMUNITY, PROFESSIONAL DIVERSION, AND OTHER SUPPORT GROUPS. IN ADDITION, THE ROOMS IS THE HOST SITE OF WORKSHOPS, SPEAKER ENGAGEMENTS, AND SPECIAL EVENTS. THIS CLASSROOM-STYLE MEETING SPACE IS AVAILABLE 24 HOURS A DAY, SEVEN DAYS A WEEK, FOR SUPPORT GROUPS. NOMINAL RENTAL IS CHARGED FOR THESE MEETINGS BASED ON THE NUMBER OF SELF-REPORTED PARTICIPANTS. IN 2011, 12-STEP GROUPS REPORTED OVER 41,000 ATTENDEES TO MEETINGS HELD AT THE ROOMS, AN INCREASE OF OVER 15% FROM THE PREVIOUS YEAR. SCHEDULES OF MEETINGS ARE REGULARLY POSTED ON THE FOUNDATION FOR RECOVERY AND ROOMS WEBSITES FOR EASY ACCESS. FOUNDATION FOR RECOVERY HELD ITS 3RD ANNUAL RECOVERY RALLY, WHICH COINCIDED WITH NATIONAL RECOVERY MONTH. OVER 400 COMMUNITY MEMBERS WITH OVER A DOZEN COMMUNITY ORGANIZATIONS PARTICIPATED IN THE EVENT WITH FEATURED RECOVERY SPEAKERS ALONG WITH LOCAL JUDICIAL AND LEGISLATIVE REPRESENTATIVES. THE ROOMS ALSO HAS LECTURES AND PRESENTATIONS GEARED TOWARDS THE RECOVERY COMMUNITY, FAMILIES AND OTHER INTERESTED PARTIES. THE FOUNDATION FOR RECOVERY'S PUBLIC OUTREACH EFFORTS INCLUDED SEVERAL NEW INITIATIVES WHICH INCLUDED BRINGING TOGETHER A DIVERSE GROUP OF MORE THAN 50 BEHAVIORAL HEALTH PROVIDERS, POLICY MAKERS, NON-PROFITS, EDUCATORS AND OTHER COMMUNITY LEADERS TO INITIATE STRATEGIES FOR BRINGING RECOVERY CONCEPTS AND OTHER RECOVERY SUPPORT SERVICES TO NEVADA. IN ADDITION, THE FOUNDATION PARTNERED WITH COX COMMUNICATION, A&E NETWORK AND THE SCHOOL DISTRICT TO LEND OUR EXPERTISE TO A LIVE TOWN HALL MEETING ON THE PRESCRIPTION DRUG EPIDEMIC. THIS LIVE BROADCAST AND ITS CONTINUED REBROADCASTS, REACHED THOUSANDS OF INDIVIDUALS IN CLARK COUNTY. OTHER COMMUNITY PARTNERS AND COLLABORATIONS INCLUDE PACT, A DRUG PREVENTION COALITION MADE UP OF MULTIPLE NON-PROFIT, GOVERNMENT, LAW ENFORCEMENT, EDUCATION AND SOCIAL SERVICE AGENCIES, SOUTHERN NEVADA MENTAL HEALTH COALITION, SPECIALTY COURT JUDGES, SOUTHERN NEVADA HOLISTIC HEALTH COALITION, AND VETERANS GROUPS. IN AUGUST OF 2011, THE FOUNDATION FOR RECOVERY BEGAN THE IMPLEMENTATION PROCESS TO BRING A PEER RECOVERY SUPPORT SERVICES TO SOUTHERN NEVADA. FFR FACILITATED A TRAINING PROGRAM FOR STAFF AND COMMUNITY VOLUNTEERS IN RECOVERY WITH APPROXIMATELY 20 INDIVIDUALS RECEIVING 40 HOURS OF TRAINING FROM THE RECOVERY ALLIANCE OF EL PASO. THE TRAINING PREPARED THESE INDIVIDUALS TO SERVE AS RECOVERY COACHES IN THE FOUNDATION'S PLANNED DROP-IN AND RECOVERY COMMUNITY CENTER, WHICH WILL OPEN IN 2012. THE MAJORITY OF PARTICIPANTS IN THE TRAINING WERE IN LONG-TERM RECOVERY AND PROVIDE A CRITICAL LINK TO THE RECOVERY COMMUNITY. EACH PARTICIPANT WAS CERTIFIED AS A PEER RECOVERY COACH. TRAINER AND WILL HELP IMPLEMENT A RECOVERY COACHING ACADEMY, THE FIRST OF ITS KIND IN THE STATE OF NEVADA. THROUGH ITS ASSOCIATION WITH THE PARTNERSHIP AT DRUGFREE.ORG THE FOUNDATION CONTINUED ITS PARENTS YOU MATTER PRESENTATIONS TO PARENTS AND OTHER COMMUNITY GROUPS. IN ADDITION, TWO SIGNIFICANT NEW WORKSHOPS WERE ADDED TO ADDRESS CRITICAL ISSUES: MUST (MEDICINE USE SAFETY TRAINING) FOR SENIORS AND FASD (FETAL ALCOHOL SPECTRUM DISORDERS) WORKSHOP FOR WOMEN OF CHILD BEARING AGE AND/ OR CAREGIVERS. THESE EDUCATIONAL OFFERINGS FILL A GAP IN SERVICES IN SOUTHERN NEVADA. RECOGNIZING ANOTHER GAP IN SERVICE IN THE RECOVERY COMMUNITY, IN 2011 THE FOUNDATION FACILITATED THE INCEPTION OF HYPER (HELPING YOUNG PEOPLE EXPERIENCE RECOVERY) TO CREATE A SUPPORT, EDUCATION AND OUTREACH SYSTEM BY AND FOR YOUNG PEOPLE. HYPER HAS ESTABLISHED A LOCAL CORE COMMITTEE OF YOUTH, BUT IS ALSO DEVELOPING NATIONAL CONNECTIONS IN THE YOUTH RECOVERY MOVEMENT. THE FOUNDATION BECAME AN OFFICIAL NEVADA RADAR (REGIONAL ALCOHOL AND DRUG AWARENESS RESOURCE) CENTER, WHICH IS DEDICATED TO PROVIDING CURRENT INFORMATION ON SUBSTANCE ABUSE PREVENTION, TREATMENT AND RESEARCH AND RELATED FIELDS SUCH AS MENTAL HEALTH. THE MATERIALS ARE AVAILABLE AT TWO SITES, PLUS ARE DISTRIBUTED AT NUMEROUS COMMUNITY EVENTS. IN 2011, THE FOUNDATION FOR RECOVERY CONTINUED ITS PRODUCTION AND DISTRIBUTION OF THE 'SOUTHERN NEVADA RECOVERY RESOURCE DIRECTORY', DISTRIBUTING OVER 15,000 (DOUBLE FROM THE PREVIOUS YEAR) WHILE ADDING NEW DISTRIBUTION CHANNELS IN THE COMMUNITY. THIS PUBLICATION, WHICH IS REGULARLY UPDATED, PROVIDES THE LATEST INFORMATION ON LOCAL RESOURCES FOR SUBSTANCE ABUSE AND MENTAL HEALTH, AS WELL AS PRO-RECOVERY PROGRAMS AND RECOVERY-FRIENDLY RESOURCES IN THE COMMUNITY. THE DIRECTORY ALSO INCLUDES LISTINGS AND CONTACT INFORMATION FOR 12-STEP FELLOWSHIPS, MEETING FACILITIES, SUPPORT GROUPS, HOTLINES, SERVICE PROVIDERS, RECOVERY-FRIENDLY RECREATIONAL ACTIVITY OPTIONS, AS WELL AS ALTERNATIVE HEALING PROVIDERS AND EDUCATIONAL INSTITUTIONS.
