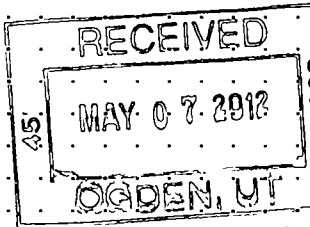

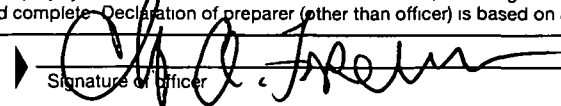

Statement of Program Service Accomplishments

1. PURPOSE:

The purpose of CASA is to recruit, equip, and send Christian professionals and volunteers to eastern Africa for a structured missionary experience. These short-term missionaries lead Christian seminars, provide training in areas of their expertise, and minister to university students, meeting their spiritual and intellectual needs. The focus of outreach of CASA is to students at the National University of Rwanda (NUR). CASA is associated with Come and See Rwanda (CASR) a registered non-profit corporation in Rwanda. The purpose of CASR is to provide discipleship training in and around Butare, Rwanda with a special focus on the students of the NUR.

2. ACHIEVEMENTS for 2011

A. Maintain the Christian Student House in Butare, Rwanda (\$ 36420)

CASA maintains a house in Butare, Rwanda, year-round near the National University of Rwanda (NUR). This is our base of operation in Africa. CASA supports this house with about \$2800 per month. This cost covers personnel, rent, supplies, and materials. In addition we support house activities with about \$3000 during each mission to Rwanda. In 2011, there was one mission. These are five Major achievements of the Christian Fellowship house in 2011.

(1) About 35 NUR students drop by the house daily for counsel, prayer, & study.

(2) About 15 students per week spend the night in one of two guest rooms at no charge. Many of these visits are overnight prayer sessions.

(3) There are Bible Study classes held in the house 6 days a week. There are about 153 students over the course of a week.

(4) In the morning the house is open to local farmers for devotions. There are typically 10 women and 30 children in house between 6 and 7 AM.

(5) During the June/July Mission Trip, two classes were offered by visiting missionaries based in the house:

1. A Pastor Seminar (27 local pastors)
2. A Student Seminar (80 NUR Students)

B. Support of Christian missionaries while in Africa (\$ 2600)

Only one missionary traveled to Africa with CASA in 2011. He was supported with \$1000 for in and around expenses: mostly food, lodging and transportation. Also, a roadside memorial was built for the missionary who died in 2010 at a cost of \$1600

C. Constructing a new campus house in Butare, called the *LightHouse* (\$ 179725)

The scope of construction has increased. The house now includes a Bible School named after the missionary who died in Rwanda in 2010 – the Kim Foreman Bible Institute. This house is intended to be a resource and refuge for university students.
