In 2011, the education department provided services to 63 students, providing 6,596 hours of instruction. Four students earned their high school diplomas. Three students passed admittance tests. Eight students were supported in attending higher education classes. The average progress students achieved in attending 6 months of tutoring in reading was an increase of 2.25 grade levels, an increase of 12.5 words per minute in reading speed, a 3.5% increase in word accuracy, and an increase in comprehension of 6%. Staff in the education department presented nationally at conferences this year including a presentation on writing at a library science conference and a presentation on learning styles and strategies and the Utah LDA conference. The education department manager received the National Educator of the Year award from NAPSEC.

The mission of clinical services is to provide opportunities for individuals with learning disabilities to increase emotional, social, and cognitive skills that lead to a more successful independent life. Clinical services provides individual and group psychotherapy, psychological testing and recreational therapy services. In 2011, the clinical department developed a social skills class and lab focusing on 4 main areas: verbal communication, non-verbal communication, conflict resolution, and relationship skills. The development of this class and lab included developing curriculum, media, and exercises including a workbook, quick reference guide, role play activities and video segments. The MAP (My Autonomy Plan) was developed and is now utilized in conjunction with other departments as the student's individual service plan. Our recreation therapy program expanded with the addition of a volunteer recreation therapy intern and a paid part-time recreation therapist. New services in recreation therapy include interest groups, small groups, and individual services.

In 2011, case management staff provided 13,787 hours of direct service to Scenicview students. Six of our seven case managers have a social service worker license and the seventh is completing her supervised hours and will be eligible for licensure in 2013. Case management staff began assisting students at their work stations. Staff spent at least one hour each week assisting the students to keep on task and modeled good work skills and a positive work ethic. Scenicview funded a bachelor level intern position in 2011. It is likely that we will have interns going forward from this time. Students work in the case management department driving other students to appointments and on errands and staff to the airport. In 2011, eight student drivers provided rides for students and staff for a total of 2,432.5 hours.
