Provided train the trainer sessions in nine locations around the state of WV on the details of the Affordable Care Act. 235 people volunteered for this training. 192 of these trainers spend 4 1/2 hours in the training session. The other 43 were trained in sessions that lasted 1 1/2 hours. We also held a follow-up meeting so the trainers could discuss what was working and what the challenges were to educating the public

West Virginia Affordable Health Care staff and volunteers made 91 presentations on the Affordable Care Act to consumer organizations, business organizations, medical providers, people with disabilities, senior citizens, social workers, state agencies and students. Slightly more than 2,900 people attended these presentations.

In 2011, WVAHC convened a health care implementation coalition. The coalition consist of consumer advocacy organizations, the faith-based community, labor organizations, the African-American community, state agencies, provider organizations, and an insurance company representative. The coalition met bi-monthly and is focused on how WV can implement the Affordable Care Act. The coalition had presentations from the WV Bureau of Medical Services (Medicaid), the WV Offices of the Insurance Commissioner(the exchange), Region 3 US Department of Health and Human Services Administrator, a Senior Advisor to Secretary Sebelius, a Legislative Aid to Senator Rockefeller, and others. The Coalition is chaired by Dr. Dan Foster, a highly respected physician, hospital administrator, and state Senator.
