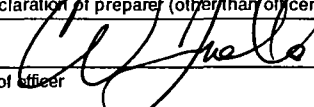

The primary purpose of SAIC Relief Foundation is to establish an employer-sponsored charitable organization to provide charitable aid to current and future employees based in the United States, and the immediate families of current and future employees of, Science Applications International Corporation and its subsidiaries who have demonstrated financial need in times of hardship or emergency as a result of a large scale natural or civil disaster.

The SAIC Relief Foundation carried out its exempt purpose through its disaster relief program. In 2011, the Foundation provided financial hardship awards to eight victims of natural disasters, including persons affected by Hurricane Irene and Tropical Storm Lee, as well as tornadoes and flooding in Alabama and flooding in Arkansas, each of whom demonstrated financial need as a result of home destruction or damage and other property loss or damage. These awards were granted by the Foundation's independent Selection Committee. The Foundation paid banking expenses for the disaster relief program. All other resources in support of the disaster relief program were provided by Science Applications International Corporation.
