According to the World Food Program, it is estimated that only 20 percent of children attend primary school in South Sudan, which is working hard to build an infrastructure following two decades of war Education is a key component of developing this new nation, and there is an immense and urgent need to build schools, which provide clean water and school lunches Former NBA athlete and humanitarian Manute Bol had a dream of building schools for children of all ethnic, tribal, and religious backgrounds The Manute Bol Primary School in Turalei is an ongoing project in the home village of Bol, who believed the most important factor for the future and stability of South Sudan was education for its children At the Manute Bol school, cooks prepare meals in a newly constructed kitchen for the over 500 children who attend the school with food provided by the World Food Program The Daniel Kuot Primary School in Paloi serves over 300 children taught by four teachers under the shade of trees Fundraising efforts continue to support these teachers and work toward the goal of building a permanent structure for the children to attend school Project Director, Daniel Kuot, also manages funding being raised and provided for South Sudanese children to attend the Loki Light Academy in northern Kenya Sudan Sunrise continues to support and facilitate grassroots reconciliation efforts of Sudanese in Sudan and South Sudan to ensure lasting peace and the end of oppression Ongoing reconciliation projects include a project in which Muslim students from Sudan, South Sudan and the United States are working to rebuild a Catholic church in Tont, South Sudan, and facilitating and supporting the Sudanese diaspora community in the United States and Canada participate in ongoing peace and reconciliation initiatives in Jonglei State, South Sudan
