We identified partners in education, journalism, inter-faith, and nonprofit capacity building and developed digital programs around them. Through these projects, Meedan forwarded new models of multi-lingual interaction design, machine-assisted translation, and open source translation workflow

Partnership Development for Civic Capacity - In 2011, Meedan identified an increasing need for sustainable, extensible open source technologies to support partners working in knowledge and communication projects in the Middle East, particularly in multi-lingual settings. Meedan supported 13 communication partners to envision and build their digital interventions, expand their reach and capacity, and engage more Middle East citizens in dialogue and information exchange
