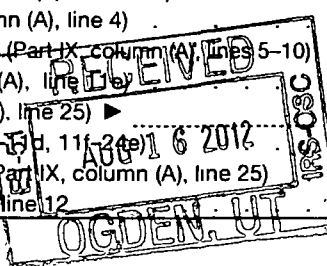

Micro Church Planting. Our main service as an organization is to help initiate and grow micro churches reaching different groups of people in the city. In 2011, we have continued to expand internationally. We started construction of a community center in Haiti and our office in Manila has filed for their own non-profit status. These small churches provide many services to people in our community. They range from small fellowships that meet in people's homes to more wholistic ministries. Some of these ministries provide care and housing for women seeking to leave the sex or young teenagers aging out of foster care system. We provide ongoing training and support for their leaders, as well as, providing a financial structure for their ministry.

Ministry Center. this program expense provides for a multi-use classroom and office space for many of the small ministries and micro churches. During 2011, we were able to host an arts event, hold classe during the spring, summer and fall. We added office space to house 2 more ministrie and 8 more staff.
