Conducted theatrical, dance and music productions by Persons with Disabilities ("PWD") as the actors, performers, set designers, producers, assistants. The workshops, classes, rehearsals and trainings are conducted by PHAME staff and also by outside artists. Approximately twenty-eight persons participated in the classes, workshops, rehearsals and productions for three days per week for approximately three hours per day. Amount of expenses is estimated.
