Deputy Cruser, the Treasurer/Secretary, provides a copy to the sheriff, who is the Chairman of the board, and also e-mails the other four members of the board that the tax return is available in the sheriff's office for review. Also, since this is an annual event in a small town, most of the information is already well known through newspaper coverage and the Sheriff's Office website.

Part VI, Line 19 - How does the board make its governing documents, conflict of interest policy and financial statements available to the public?

The board does not have a separate "conflict of interest" policy, but uses the one that the county has adopted. The policy for the county is at the county courthouse if the public wants to look at it.

The governing documents of the board and the tax return are available at the Sheriff's Office for review by the public. Other than a checkbook, and a cash receipt/disbursement report, there are no "financial statements." The activity of the annual charity ride encompasses more logistic than financial effort. For example, the 2011 ride caused 38 checks to be written, which included the 8 checks for the money given to the 501(c)(3) charities. In summary, the planning activities usually go on for 4 to 6 months, while the financial activity continues on and off for about 12 weeks.
