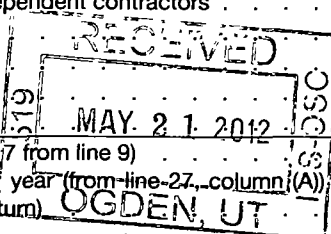

To train and equip Christian leaders internationally by conducting leadership training conferences and/or courses on Christian leadership principles to fulfill the Great Commission of Jesus Christ as well as provide leadership training manuals
