NightLight Atlanta is a faith-based, grassroots movement that addresses the complex issues of commercial sexual exploitation through prevention, intervention, restoration, and education NightLight Atlanta's Prevention Program has launched in two locations since 2008 and now serves over 250 at-risk children and teenagers NightLight Atlanta will launch a third program in 2012 Every week, the NightLight Atlanta Outreach Team builds relationships with individuals who are working in strip clubs, brothels, and hotels, individuals soliciting on the street, individuals who are pimping, and individuals who are buying sex The NightLight Atlanta Outreach Team ministers to an average of over 500 women in the sex industry every year (Note This number does not include men)NightLight Los Angeles handles jewelry distribution and sales, customer service, and marketing within the US In addition, The Los Angeles office also manages the administrative requirements of the US 501c3 which actively sustains the work of NightLight International worldwide NightLight Los Angeles plans and implements key anti-trafficking programs designed to impact the issue on a local level NightLight Bangkok provides economic alternatives and leadership development through employment, job training and life skills training at NightLight Design, Co , Ltd The NightLight Bangkok outreach team maintains a presence in the red-light district of Nana Sukhumvit, building relationships with women and children, and offering them a way out of their situation In Bangkok, the NightLight outreach team meets hundreds of women and children every year through bar visits and street level interactions NightLight Bangkok assists in the rescue of a number of women from Central Asia and Africa since August 2007 NightLight provides emergency relief for women and children at risk in the Nana/Sukhumvit area and engages in local and international advocacy on behalf of women and children working in the sex industry
