

CICAS conducts research in the development of surgical navigation equipment and techniques.

Form 990-EZ, Part III, Line 28 - Statement of Program Service Accomplishments

In 2011, CICAS worked on the conceptualization, design and development of targeted liver cancer therapy system using a robotic arm and CT-based surgical navigation system. Moreover, in 2011 and continuing into 2012, CICAS has been working independently to design the next generation surgical ablation systems by utilizing dynamic sources of imaging (i.e., Ultrasound Imaging) as means for interactive intra-operative guidance of minimally invasive surgical tools to the targeted pathology. The results of the research and development for the former efforts have yielded a commercial product and are being currently distributed through Perfint Healthcare. The latter on going research involving Ultrasound navigation have yielded an early stage functional prototype illustrating the feasibility of dynamic and automated surgical guidance in soft moving tissue such as for the treatment of cancer lesions in the lung.
