Our mission is to support cancer patients in Solano County, California.

The organization paid for mammograms and diagnostic tests for many individuals in Solano County that could not afford to pay for the services. Additional individuals were provided assistance to help pay for rent, utilities, etc. during a short period of time while unemployed and undergoing cancer treatment.

Individuals benefiting from the foundation lived in most of the seven cities of Solano County.
