**Limuru Children's Centre (LCC)** Relocated and re-modeled a new kitchen, including stoves and cooking equipment. Developed the Christmas Gift Program which fed 36 children for two weeks, sent 37 children to primary school for a year. Started a sustainable model of support, The Godparent Program, which increases monthly financial support and facilitates better education in English reading and writing, and enhances the relationship skills of the children.

Mrs. Pat Dixon has helped many children with her compassion, support, wisdom and direction. She brings toys to children in the hospital, hundreds of blankets to the children of the community and a bimonthly feeding program. Mrs. Dixon is a British native of Kenya.

**Jikaze Village** is a group of IDPs (Internally Displaced Peoples). There are about 145 families, approximately 1,000 people, in this village who were forced to leave their homes after the Post-Election Violence of 2007. Global Connections and its partners together have built 54 houses, subsidized 75 water filters, provided 90 micro-finance loans, provided 36 educational scholarships, planted 270 trees, conducted three months of food relief and currently are creating social businesses around tomatoes, shoe-making and chicken rearing.
