Our primary means of providing physical and connectional support to our target people groups is through sending small teams of volunteers to perform training, construction, project management, and medical care. Thus expenses in this category are related to travel, lodging, food, water, and materials provided to members of the target group.

4b (Code:) (Expenses \$ 46,196 including grants of \$) (Revenue \$)

In 2011, RHI provided support for the creation of a local American-style restaurant in the Croix-des-Bouquets community in Haiti. This restaurant project was designed to create steady employment for some 18 individuals, enabling them to provide for their families and resume school (which requires tuition in Haiti), as well as provide career training for young people entering the job market.

RHI provides monthly food, education, and clothing assistance to 63 orphans, and also feeds 1,500 other Haitians in an ongoing food evangelism program. This is accomplished through financial assistance to Souls Winning Ministries, who operate the orphanage, manage the school, and administer the church.
