IN 2011, OK HUMANE PERFORMED 12,717 SPAY/NEUTER SURGERIES AND PERFORMED 1,589 STERILIZATIONS ON FERAL CATS. IN 2010, OK HUMANE HIRED 2 PART-TIME EMPLOYEES CALLED SPAY/NEUTER LIAISONS. THESE EMPLOYEES WORK DIRECTLY IN THE TARGETED ZIP CODE NEIGHBORHOODS GOING DOOR TO DOOR PROMOTING SPAY/NEUTER. THE OKLAHOMA CITY ANIMAL SHELTER SAW AN 1,180 ANIMAL DECREASE IN INTAKE FOR 2011 FROM THE TARGETED ZIP CODES AFTER ONE YEAR OF PLACING THE SPAY/NEUTER LIAISONS IN THE NEIGHBORHOODS. THE OK HUMANE ADOPTION PROGRAM PERFORMED 2,749 ADOPTIONS IN 2011 AND FEATURED A NUMBER OF FEE REDUCED SPECIALS. OK HUMANE ALSO HOSTED TWO MIDNIGHT WOOFNESS EVENTS. THE SPRING EVENT PERFORMED 586 ADOPTIONS AND THE FALL EVENT WAS THE BIGGEST MIDNIGHT WOOFNESS EVER WITH 586 ADOPTIONS IN A 48 HOUR PERIOD. IN LATE 2011, OK HUMANE WAS FUNDED TO IMPLEMENT A NATIONAL MENTORSHIP PROGRAM FOR MEGA-ADOPTION EVENT MANAGEMENT. ALSO IN 2011 CONSTRUCTION BEGAN ON THE HOMEWARD BOUND QUARANTINE FACILITY SLATED TO OPEN IN SPRING OF 2012. THE BUILDING WILL BE DEDICATED TO PROVIDING A LOCATION TO QUARANTINE DOGS AND PUPPIES TRANSPORTED OUT-OF-STATE FOR ADOPTION. EACH OF THESE VARIED METHODS OF ADOPTION WILL CONTINUE TO DIRECTLY INCREASE THE LIVE RELEASE RATE.
