Latino/a Visual Imaginary: Intersection of Form & Function

The exhibition featured major on-site installations by Amalia Mesa-Bains and Pepon Osorio, and the work of Viva Paredes, Elena Baca, Kai Margarida-Ramirez de Arellano, Yreina Cervantez, Jose Montoya, Wanda Raimundi-Ortiz, Santos Contreras, and a tribute to Spain Rodriguez. The exhibition was the central part of a larger collaboration titled *Latino/a Imaginary*, which included related exhibitions at UNM's College of Fine Arts, Zimmerman Library, Center for Southwest Research (CSWR), and Tamarind Institute of Lithography, and with The Albuquerque Museum of Art and History, National Hispanic Cultural Center (NHCC) and Outpost Performance Space in March and April. In addition, the project was scheduled to coincide with the conference *Latino Literary Imagination: East Coast/South West Dialogue on Narrative and the Spoken Word* (April 14–16), a collaboration among The University of New Mexico (UNM), Rutgers University, Nuyorican Poets Cafe and the National Hispanic Cultural Center. Curated by Dr. Holly Barnet-Sanchez, Associate Professor, Chicano/a, Latino/a and Latin American Art History and Associate Dean, College of Fine Arts at The University of New Mexico. Across the Great Divide

This was a solo exhibition of the photographs of Roberta Price, taken during the back-to-the-land movement, which served as a point of departure for examining issues of autonomy and community today. The exhibition was held in conjunction with the release of her book *Across the Great Divide: A Photo Chronicle of the Counterculture* (UNM Press, 2010), a photographic archive of hippies, communes, architecture, countercultural luminaries and events in the Southwest in the late 1960s and 70s, capturing the hope, optimism and utopian promise that fueled that period. Curated by Mary Anne Redding, Curator of Photography, Palace of the Governors/New Mexico History Museum. 516 ARTS, in partnership with The Museum at Bethel Woods, NY, organized a national tour of the exhibition. Catalog essay "The Counterculture Photographs of Roberta Price" by Mary Anne Redding.

World Outside This One

Concurrently with *Across the Great Divide*, 516 ARTS hosted a related exhibition in the downstairs gallery, organized by guest curator Erin Elder. *Worlds Outside This One* featured a group of emerging international artists and innovators responding to the legacy of homesteading, squatting, hermitage and fort building. It addressed the urge for momentary acts of self-determination, showcasing hand-hewn spaces in the gallery and interactive experiences, as well as blueprints, shelters, journals and maps. The exhibition illuminated the productive tension between Do-It-Yourself autonomy and shared notions of utopia. Many of the artists are also architects, philosophers, entrepreneurs, urban planners, economists and community builders. Featured artists: Justin Bagley (NM), Amy Balkin (CA), Michelle Blade (CA), Building a Nation (collective: Columbia, Philippines, Norway), Siraj Izhar (England), Jed Lind (CA), Elysa Lozano for Autonomous Organization (NY), Mary Mattingly (NY), Travis Memolf (Germany), Meow Wolf (NM collective), Jay Nelson (CA), N55 (Denmark), Mia Nussbaum (CO), David Ondrik (NM), Stephanie Smith (CA), Swimming Cities (NY collective), David Wilson (CA). Curated by Erin Elder, independent curator, writer and teacher, who wrote the catalog essay titled "Fort-Building or the Path to Radical Social Change."

Arnold Valdez, an Adjunct Associate Professor at the UNM School of Architecture and Planning, was chosen for his expertise in alternative materials and methods of construction, and cultural landscape planning.

Superheroes: Icons of Good, Evil & Everything in Between

This multimedia group exhibition about heroes, villains, and other less-definable examples of human possibility, explored notions of identity both real and imagined. Using iconic images to examine the ways in which we absorb, react to, and adopt heroic archetypes, the exhibition examined how notions of the “super” inspire, define and rationalize behaviors. Through mixed-media sculpture, painting, video, textiles, photography and on-site murals, the exhibition featured heroic representations of humanity’s light and dark sides. Informed by pop culture notions of “Super”—both hero and villain—it examined the profound effect images of Superhero and Supervillain archetypes, generally seen as pop culture ephemera, have had as they became integrated into our culture, influencing our conceptions of race, morality, civil responsibility and human achievement. Participating artists were: Esteban Bojorquez (Santa Fe, NM), Boneface (Liverpool, England), Aaron Campbell (Albuquerque, NM), David Cudney (Albuquerque, NM), Lawrence Getubig (Washington D.C.), David Gremard Romero (San Francisco, CA), Ben Johnsen (Albuquerque, NM), Joel Jonientz (Grand Forks, ND), Mark Newport (Bloomfield Hills, MI), Aaron Noble (Los Angeles, CA), Marc Ouellette (Albuquerque, NM), Min Kim Park (Chicago, IL), Dulce Pinzon (Mexico City), Cullen Washington, Jr. (Boston, MA), Jolene Yazzie (Santa Fe, NM). The exhibition also featured a looped program of short films titled *It's a Bird, It's a Plane*—curated by Bryan Konefsky. Curated by 516 ARTS with Neilie Johnson through a combined invitational and juried process. Catalog essay “Who Wants to Be a Superhero” is by Neilie Johnson, a freelance writer and art director specializing in popular media.
