During 2011, NNCCF's Family Assistance Fund aided eighty eight families, spending \$170,600 in direct financial support by providing coverage for a variety of expenses related to treatment, including medical expenses, insurance deductibles, uncovered procedures, household living expenses, mortgage payments, rent, food, utilities, travel expenses. Over 50 patients, siblings and family members attended support group events such as Reel Kids Fly Fishing day. NNCCF raised \$147,000 to help fund a cure. Over the holidays NNCCF had 342 family members attend the annual Holiday Party and had 31 families adopted for Christmas.
