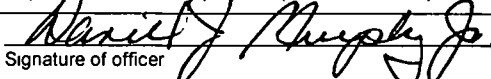

NOTES TO FINANCIAL STATEMENTS

December 31, 2011

Note 1 - Organization and Operation:

Champions of the Community, Inc. (the Organization) is a not-for-profit corporation established in 2007 which operates the Nationwide Children's Hospital Invitational, an annual event on the Nationwide Tour. Proceeds from the event benefit central Ohio based charitable organizations, principally pediatric cancer research and treatment at Nationwide Children's Hospital.

Note 2 - Summary of Significant Accounting Policies:

The financial statements conform to accounting principles generally accepted in the United States of America applicable to not-for-profit organizations. They are prepared in accordance with the accrual basis of accounting, and reflect all significant receivables, payables, and other liabilities.

Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Income Taxes:

The Organization, is exempt from income tax under Section 501(c)(3) of the Internal Revenue Code and, therefore, is not subject to income tax.

Cash and Cash Equivalents:

The Organization, considers all short-term investments with an original maturity of three months or less to be cash equivalents.

Accounts Receivable:

The Organization, considers accounts receivable to be fully collectible; accordingly, no allowance for doubtful accounts is required.

Deferred Revenue:

Deferred revenue represents sponsorships that have been paid in advance.

Concentration of Credit Risk:

The Organization maintains its cash in bank deposit accounts which, at times, may exceed federally insured limits. The Organization has not experienced any losses in such accounts and does not believe it is exposed to any significant credit risk on cash and cash equivalents.

Note 2 - Summary of Significant Accounting Policies (continued):

Financial Statement Presentation:

The Organization, reports information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets. As of December 31, 2011, the Organization has unrestricted net assets only. The Organization is also required to disclose, on a functional basis, costs associated with each program. Substantially all of the expenses incurred by the Organization relate specifically to the Organization's primary program, to operate the Nationwide Children's Hospital Invitational tournament to benefit central Ohio based charitable organizations. Any expenses incurred which do not directly relate to this program are deemed immaterial for financial statement purposes and therefore, are not shown separately.

Advertising:

The Organization, expenses advertising costs as incurred. Advertising expense amounted to \$97,177 and \$112,145 for the years ended December 31, 2011 and 2010, respectively.

Note 3 - Accounting for Uncertainty in Income Taxes:

The Organization has adopted the provisions of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) relating to uncertain tax positions. The Organization does not believe its financial statements include any uncertain tax positions. The Organization is no longer subject to U.S. federal, state or local tax examinations by tax authorities for years before 2007.

Note 4 - Subsequent Events:

Subsequent events have been evaluated through February 7, 2012, which is the date the financial statements were available to be issued.
