Grant Procedures

Pursuant to Section 501(c)(3) of the Internal Revenue Service Code of 1986, as amended, and the Treasury Regulations thereunder (the "Code"), the Board of Directors of the Chambers Family Foundation, Inc. (the "Foundation") has adopted the following procedures in the awarding of grants to organizations.

1. The Selection Process - Candidates for Grants

Grantees shall be individuals or organizations, selected on the basis of criteria and in the manner determined from time to time by the Board in its discretion and the then-existing demands on Foundation funds, in furtherance of the Foundation's charitable objectives and in accordance with the Code. Grants may be one-time grants or continuing grants as the Board shall determine in its discretion. Recipients shall be those individuals or organizations which the Board shall from time to time designate. On the basis of criteria relating to the particular grant program involved, a grantee may be selected from a group of qualified individuals or organizations or without reference to a group of organizations as the Board shall determine. The person or persons who select recipients shall not derive a private benefit, directly or indirectly, if certain potential grantees are selected over others. Neither employees of the Foundation nor "disqualified persons" (as defined in Code Section 4946) shall be eligible for grants.

2. Terms and Conditions Under Which the Foundation Makes Grants

The Foundation may make restricted or unrestricted grants. In the case of restricted grants, the terms and conditions (if any) of each grant to an individual or organization shall be contained in a letter sent to each recipient of such a grant. The

recipient may be required to communicate its acceptance thereof by a letter in writing to the Foundation. Terms and conditions may include specific purpose of the grant, its duration, the total amount of the grant and requirements for narrative reports, including due dates for such reports, if any, and such other information as the Board may from time to time request. In each case, it shall be stipulated that a renewal of the grant for any succeeding period, if the terms of such grant provide for any such renewal, is contingent upon evidence of adequate performance at the time of review.

3. *Procedures for Review of Grantee Reports, for Investigation Where Diversion of Grant Funds from Their Specified Purposes Is Indicated, and for Recovery of Diverted Grant Funds*

(a) *Review of grantee reports*

In the case of restricted grants, the Foundation or its designee shall have the responsibility to follow the progress of the grant, that is, to review each report submitted by the funded individuals or organizations, to make a determination as to whether the grant purposes are being or have been fulfilled and to address any questions requiring further scrutiny or investigation.

(b) *Investigation where diversion of grant funds from their specified purposes is indicated*

In the case of restricted grants, where reports to the Foundation or other information (including failure to submit reports after a reasonable time has elapsed after the due date) indicates that all or any part of grant funds are not being used for the purposes of such grant, the Foundation shall initiate an investigation. While conducting the investigation, the Foundation may withhold

any applicable further payments to the extent possible until it has determined that no part of the grant has been used for improper purposes, and until any delinquent reports have been submitted

If the Foundation determines that any part of a restricted grant has been used for improper purposes, the Foundation may at its option elect to either (i) terminate the grant and take all reasonable and appropriate steps recover the diverted grant funds or (ii) take all reasonable and appropriate steps to insure the restoration of diverted funds to their proper purpose and receive assurances acceptable to the Board in its discretion from the grantee that all additional grant funds held by the grantee shall be dedicated solely to the purposes being financed by the grant.

In the case of restricted grants, the Foundation may take legal action to recover any diverted grant funds, unless such action would in all probability not result in the satisfaction of execution of a judgment. Without limiting the right of the Foundation to terminate the grant pursuant to the immediately preceding paragraph, if the Foundation determines that any part of a restricted grant has been used for improper purposes, the Foundation may withhold any applicable further payments on the particular grant until it has received the grantee's assurances that future diversions will not occur, any delinquent reports have been submitted, and it has received evidence satisfactory to the Board in its discretion that the grantee shall take extraordinary precaution to prevent future diversions from occurring.

4 *General Provisions*

These procedures shall be periodically reviewed by the Board of Directors to determine their effectiveness. The adoption of these procedures shall not prevent the Foundation, in its sole discretion, from limiting or discontinuing all or any part of its grant programs.
