The dominant expense is web hosting fees. Appropedia.org web hosting services are provided by Dreamhost. Fees vary both up and down as the web traffic increases over time (with increasing content and increasing viewership), but hosting fees decline somewhat as well.

For 2011, total web hosting fees were \$1090 dollars. Bank fees were \$2. Total expenses were therefore \$1092 for the year.
