	The Cathedral Soup Kitchen serves the poor and homeless of the Camden, NJ area. During the year CSK expanded the capacity for the daily meal service to include Saturday meals. Over 120,000 meals were served. CSK started a new program that provides meals to local shelters, children's after-school programs and food for small pantries and soup kitchens. They also started the operation of a health care facility on the premises in partnership with Project H O P E and the South Jersey Eye Center and the Project Smiles Dental Clinic staffed by area dental professionals. During a prior year CSK started a Culinary Arts Training Program to teach job skills to impoverished individuals. Two 17 week classes are held each year.
