THE MONASTERY, IN PARTICULAR, USUALLY GREETED UP TO 6 TOUR BUSES OF VISITORS AS THEY PAY RESPECT TO BUDDHA, OFFER PRAYERS TO THEIR DEPARTED RELATIVES, AND TAKE PART IN THE CELEBRATION OF NEW YEAR AT THE MONASTERY. THE VEGETARIAN LUNCH OFFERED TO ALL.

BUDDHIST DISCIPLES GATHER AT THE MONASTERY TO PAY RESPECT, AND LISTEN TO DHARMA TEACHING, AS WELL AS ENJOY THE VEGETARIAN CULINARY EXPERIENCE. 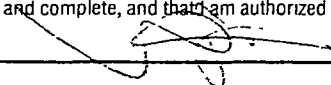
