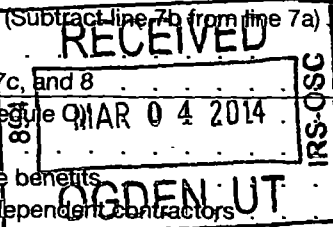



The Marietta Police Athletic League (MPAL) co-hosted the third annual Youth & Law Enforcement Symposium with the purpose of bridging relationships between area youth and law enforcement. MPAL continued its involvement in / sponsorship of the 6th Grade Basketball Program, summer swim lessons, tutoring program, YELLS Mentoring Program, martial arts lessons, Early Learning Initiative, and the Family Stability Project. New for 2011 was providing a sponsorship to area youth for the First Light Track Club, Spanish classes, and photography classes.
