Pennsylvania State University had set these funds aside in an interest-bearing account called the Gittlen Foundation Fund. Annual pledges made to the JGCRF by the Tournament were fulfilled by the transfer of funds from the Gittlen Foundation Fund until the total balance at the University was expended. From then on, the Tournament fulfills the pledges directly from their current accounts. During early 2011, the balance was fully expended.
