Multiple projects financed primarily by Earth Conservancy related to the reclamation and return of former coal company-owned land in the region, including the operation of a yard waste compost facility utilized by 18 Luzerne County communities. The facility processed approximately 8,000 tons of material, substantially all of which will be used in land reclamation / improvement projects.

Remediation of acid mine drainage in Espy Run and at the Askam Borehole, primarily funded by grants. In addition to the above direct expenditures there was an additional \$12,130 contribution of professional services for engineering design and supervisory services.

Design and development costs relative to the reclamation of Hanover 9, a 300 acre parcel that was a former strip mine site and is in the vicinity of Luzerne County Community College and near center city Nanticoke. The project is primarily funded by grants.

At the Board meeting, the draft Form 990 is reviewed and if revisions or modifications are recommended by the Board, such modifications are made to the tax return and it is timely filed.
